# Treasurer's Report

Overall our finances have been we have. If there is a problem, good. There have been no unexpected repairs or expenses to come out of our budget this year.

As for dues, we only have two homeowners that are a vear past due. One has contacted us to work out a payment plan, the other needs to ASAP! If they do not contact us to work out a solution, the next step will be filing in small claims court for the dues owed, plus any court fees associated with the collection. I realize that this has been a tough year for a number of us due to the economy, but the homeowners dues are still an obligation that

please contact me and we'll work something out.

I've been asked why we still have a reserve fund and the CD that accrues interest for us. The amount is less than half of our annual budget, and the board feels that keeping the amount in the reserve and the CD will eliminate any need for an added assessment for an unexpected cost or repair. Our CCR's & By Laws allow us to charge for 'special assessments' if necessary in this instance, but we would rather try to keep our dues at their current rate of \$135/year and not have the need for other assessments.

#### **HOLIDAY SAFETY**

During one of the highest crime times of the year, please take the following precautions to ensure the safety of you and your family:

#### Before You Shop

- Avoid carrying a purse. Use a fanny pack or deep pockets in clothing to carry what you need
- \* Carry small amounts of cash
- \* Carry your keys, cash and credit cards separate from each other
- \* Be extremely careful using ATM machines. Use them in populated places and be constantly paying attention to what's going on around you
- \* If you're not sure a shopping bag will be available to you, take one of your own to the mall. Consolidate as many packages as possible

#### While Shopping

- \* If you have to carry a purse, carry it close to your body and always zipped
- \* Park strategically--close to the mall is optimum. Park in well-lit areas. Never park next to a van
- \* Know exactly where you park your car. Make a mental note or write it down so you will know exactly where to go when you I leave the mall

#### After Shopping

- \* Leave the mall well before closing time. This way, there is greater assurance you will walk out with other people. There is safety in numbers
- \* Avoid shopping until you are exhausted. You are more alert when you are less tired

- \* When hurried or in a crowded shop, make sure you get all forms of I.D. and credit cards returned to you before leaving
- \* Use an escort or mall security if you have too many packages or if you are leaving the mall after closing
- \* Check underneath your car as you approach it. This is a common ploy of criminals in mall parking lots and they will take you by surprise
- \* When going from mall to mall, keep your packages stored out of sight in the trunk of your car.

#### At Home

- \* Keep gifts hidden from view through outside windows
- \* After opening gifts, break down cardboard boxes of expensive

#### **Compliance Committee Notes:**

A **BIG THANK YOU** to everyone who helps makes the committee's tasks fairly simple. If you've driven down Main Street lately you've probably noticed that the brick wall is finally fixed. What an ordeal! Again, thanks to the diligence and excellent record keeping of our Homeowners Association the problem was solved.

#### **Home Tips:**

Speaking of walls, it may be time to take a look at our own home exteriors. Many of our homes are approaching 10 years old. Many of our homes are in need of exterior wood trim painting. The committee regularly patrols the neighborhood and it is becoming more evident that many of the Ridgepointe homes are in need of a good coat of paint. If your home is over five years old or you haven't painted in five years its probable time to consider a good paint job or alternative exterior siding. This hot Texas sun really deteriorates exterior paint a lot faster than you can imagine. Keeping up the exteriors of our homes adds value to our investment.

#### **Roof Damage:**

Don't forget to check the roof! The spring storms affected many roofs in Ridgepointe. If you haven't already done so, have some professional roofers check it out. We had hail damage and would never have known except for the roofer that came to patch some loose shingles. Contact your insurance company and/or a reputable roofer. If you do check with a roofer be sure to check the BBB to assure that the roofer is reputable.

<u>Reminders:</u> Any structure changes must be approved by the architecture committee.

#### Use restrictions outlined in the RHOA's bylaws:

Section 9. Parking. No vehicles, trailers, implements or apparatus may be driven on parked in the Common Maintenance Area or on any easement. Parking of any vehicles in yards front, back or side is prohibited unless

already outlined in other sections. Vehicles are prohibited from parking on non-paved areas.

#### Section 19 Grass and Weeds.

Yards shall be maintained in such away that promotes the standards of the Association. Beds to be cleaned of all weeds. Grass to be maintained below 6 inches. Yards are to be made up of typically available and accepted grass types. Edges between grass and other medium shall be trimmed and/or edged. Regular seasonal lawn care shall be maintained. IE: fertilized, watered, weeded, mowed and trimmed. Other vegetation shall be properly trimmed and maintained. Upon failure to maintain any Lot, the Declarant or the Association may, at its option, have the grass, weeds and vegetation cut as often as necessary in its judgment, and the owner of such property shall be obligated, when presented with an itemized statement, to reimburse said Declarant or Association for the cost of such work.

Section 18. Seasonal Decorations. Outdoor seasonal decorations must be in working order, good repair, and shall mot become a fire hazard or threaten public safety. Decorations will be set up and taken down in a timely manner

Section 21 Single-Family Use. Each residence may be occupied by only one (1) family consisting of persons related by blood, adoption, or marriage or no more than two (2) unrelated persons living together as a single house keeping unit. This Section does not prohibit occupancy of the residence by household servants along with the permitted occupants described in this Section.
